

# **SHARE & BE REWARDED**

### **TERMS AND CONDITIONS**

These terms and conditions ("Terms and Conditions") shall apply to the **SHARE & BE REWARDED** ("Giveaway") organised by Republic Auto Pte Ltd ("Republic Auto").

By taking part in this Giveaway, you agree to be bound by these Giveaway Terms and Conditions and the decisions of Republic Auto in relation to and in connection with this Giveaway.

# 1. ELIGIBILITY:

- 1.1 To participate in the Giveaway, only persons who have purchased a pre-owned passenger vehicle with a valid Sales Agreement at Republic Auto and such persons shall be referred to as an Eligible Customer ("Eligible Customer").
- 1.2 The Republic Auto showrooms are located at:
  - (a) 209 Pandan Gardens, Level 3, Singapore 609339
  - (b) 239 Alexandra Road, Level 2, Singapore 159930.
- 1.3 Republic Auto reserves the right to amend the qualifying period.
- 1.4 For the avoidance of doubt:
  - (a) Each Eligible Customer shall be at least 18 years old and shall be in possession of an Identity Card which is eligible for use in Singapore.
  - (b) The following categories of persons are not eligible to participate in the Giveaway:
  - (c) All permanent and/or contract employees ("Employees") of Republic Auto, Jardine Cycle & Carriage Limited and its subsidiaries and affiliates ("JCCL").
  - (d) All agencies and/or service providers engaged by Republic Auto, Jardine Cycle & Carriage Limited and its subsidiaries and affiliates ("JCCL") (including but not limited to advertising agencies, promotions agencies, printing companies, event management agencies and any persons assisting or who are involved in the Giveaway) and their employees.
  - (e) All dealers and/or distributors of the products of the Republic Auto, Jardine Cycle & Carriage Limited and its subsidiaries and affiliates ("JCCL") and their employees.
- 1.5 Notwithstanding the aforesaid, Republic Auto has the absolute discretion to determine the eligibility of participants. Such determination shall be final and conclusive, and Republic Auto is not obliged to give any reason for its determination.

#### 2. PROMOTION MECHANICS

- 2.1 Each Eligible Customer is limited one (1) entry into the Giveaway by completing the following steps:
  - (a) Share a picture of your car and tell us about your purchase experience at Republic Auto on Instagram and/or Facebook.



- (b) The post must be public and tag the official Republic Auto account on Instagram (@republicautosg) and/or Facebook (@Republic Auto).
- 2.2 One (1) entry per Eligible Customer will be counted, based on the following conditions:
  - a. Each entry must be associated with a unique social media account (one Instagram or Facebook account) and username.
  - b. Multiple posts from the same account will not increase the number of entries; only one (1) entry per account is allowed.
  - c. In the event of multiple entries from the same Eligible Customer, only the first valid entry will be considered.
- 2.3 For the entry to be valid, the following criteria must be met:
  - a. The social media post must be set to public and remain visible to Republic Auto's official account throughout the duration of the Giveaway.
  - b. The picture and review must be original content created by the Eligible Customer.
  - c. The post must correctly tag the official Republic Auto account (@republicautosg on Instagram and/or @Republic Auto on Facebook).
  - d. Republic Auto reserves the right to verify the authenticity of entries and disqualify any entries that are found to be fraudulent, duplicated, or in violation of these Terms and Conditions.

# 3. PRIZES:

- 3.1 There will be three (3) Giveaway winners ("Winners") and the prizes ("Prize") are:
  - (a) Top Prize Winner: \$1,000 worth of shopping vouchers
  - (b) Two Consolation Winners: \$250 worth of shopping vouchers each
- 3.2 The winners for the Giveaway Winners will be selected from the eligible participants according to:
  - (a) Top post with the largest number of likes wins \$1,000 worth of shopping vouchers.
  - (b) Two other posts with the second-largest number of likes will each receive \$250 worth of shopping voucher.

- 3.8 If a Winner fails to produce the required personal identification documents, his/her respective prize will be forfeited (without any liability on the part of Republic Auto to any person).
